The **United Republic of Tanzania has received** financing from the **Kuwait Fund for Arab Economic Development (KFAED)**, **Saudi Fund for Development (SFD)** and **Arab Bank for Economic Development in Africa (BADEA)** toward the cost of the **Rehabilitation and Expansion of Mnazi Mmoja Hospital - Zanzibar** and intends to apply part of the proceeds toward payments under the contract for **Rehabilitation and Expansion of Mnazi Mmoja Hospital - Zanzibar**. For this contract, the Borrower shall process the payments using the Direct Payment disbursement method, as defined in the **Kuwait Fund for Arab Economic Development (KFAED)**, **Saudi Fund for Development (SFD)** and **Arab Bank for Economic Development in Africa (BADEA)** disbursement Guidelines.
2. The **Ministry of Health** now invites sealed Bids from eligible Bidders for **[Construction of new buildings at the Mnazi Mmoja main campus, Rehabilitation of the existing buildings at the MMH main campus, Demolition and construction of a new maternity hospital (5 floors) at the same location of Mwembeladu**

*hospital, Construction of new ground floor buildings with provisions for future expansion and Rehabilitation of the existing wards at Kidongo Chekundu mental hospital and Supply of electrical and mechanical installations], the construction period is **twenty (20) months** and defect liability period is **twelve (12) months** and all sites are allocated in **Unguja - Zanzibar**.*

3. Bidding will be conducted through international competitive procurement using Request for Bids (RFB) as specified in the **Kuwait Fund for Arab Economic Development (KFAED), Saudi Fund for Development (SFD) and Arab Bank for Economic Development in Africa (BADEA)** and is open to all eligible Bidders as defined in the Procurement Regulations.
4. Bids will be evaluated in accordance with the evaluation process set out in the bidding documents. The evaluation shall be based on compliance with the mandatory technical requirements specified in the bidding documents. Among the bids that meet these mandatory requirements, the contract shall be awarded to the bidder offering the lowest evaluated cost.

The outer Bid envelopes marked "ORIGINAL BID," and the inner envelopes marked "TECHNICAL PART" will be publicly opened in the presence of the Bidders' designated representatives and anyone who chooses to attend, at the address below on **Ministry of Health, 10:30 E.A.T, on Tuesday, 24th June, 2025**. All envelopes

marked “FINANCIAL PART” shall remain unopened and will be held in safe custody of the Employer until the second public Bid opening.

8. All Bids must be accompanied by a “*Bid Security*” as appropriate of **2% of the amount of the submitted financial offer.**
9. All Bids must be accompanied by a Sexual Exploitation and Abuse (SEA) and/or Sexual Harassment (SH) Declaration.
