Notifications to Arab Contracting Companies and Consultancy Offices Regarding Projects and Technical Assistance Operations Funded by The Arab Bank for Economic Development in Africa (BADEA)

in October 2025 session

As part of the financing activities of Arab Bank, the Board of Directors, in its session held on 07 October 2025, approved the financing of several public sector operations in some African countries. These approvals include three projects in addition to ten technical assistance operations.

The total amount of financing approved during this session reached US \$127.92 million, of which US \$122.8 million was allocated to contribute to the financing of three projects, and US \$5.12 million for the financing of ten technical assistance operations. Below is a summary of the operations approved for financing:

Project Objectives

In general, the project aims to contribute to the Sustainable Development Goals—namely SDG 1 (No Poverty), SDG 3 (Good Health and Well-Being), SDG 8 (Decent Work and Economic Growth), and SDG 17 (Partnerships for the Goals)—by developing the health sector and improving the quality of health services by 2030. It also seeks to advance Africa 2063 Agenda targets, including Goal 1 (a high standard of living, quality of life and well-being for all) and Goal 3 (healthy and well-nourished citizens).

Specifically, the project aims to:

- Improve population health coverage, with the coverage rate expected to rise from 63% to 73% by 2030.
- Enhance the quality of health services by strengthening the system's capacity through the provision of 220 additional beds.
- Improve key health indicators—most notably, reduce the number of deaths from 130 per 100,000 to 70 by 2030.
- Promote medical/health tourism to the country.
